

The city of St. Clair Shores participates in the program outlined below. If you receive requests for assistance for snow shoveling, you can pass on the following information to residents. Please note that the service is limited to seniors and special needs residents. The Senior Chore Program is still accepting applications for St. Clair Shores (but other communities may be filled).

Senior Chore Service

MCCSA's Senior Citizen Chore Service assists senior citizens with home maintenance and minor repairs. The program is available to persons age 60 and older who are residents of targeted areas in Macomb County and meet eligibility guidelines.



SNOW REMOVAL

Each year a new snow removal list is created for seniors based on social and economic need. Those interested must make a new request every year. Notification will be mailed in early December to those who have been placed on the snow list. Snow removal is performed after a snowfall of two or more inches. Under normal conditions, snow is cleared within one to five days of a snowfall. To make a job request call the phone number for your community as listed [below](#).

Use the following sliding scale to determine your suggested cost for service per visit.

Seniors requesting Chore Service are expected to share in the cost of providing the service. For each service performed, the senior should make an appropriate contribution. No one will be excluded from receiving services if their income does not permit them to contribute at the recommended level.
